Letter grades, percentages and GPA are offered on all full transcripts for students. All coursework is completed on a pass/fail basis with a C+ being the minimum passing grade. All coursework must receive a PASS for completion of Degree Programmes.

Transfer Credit

Trinity accepts the transfer of academic credits from vocational schools, colleges, universities and other recognized educational institutions at the value recorded on official transcripts.

Credit for Experiential Learning

In accordance with the practices of other recognized institutions of further and higher education, Trinity grants academic credit for employment learning, training, training during military service, independent study and other significant learning experiences. Credit may be awarded for Lifelong Learning outside the formal classroom when such education is shown to meet the objectives of standard academic courses. Either elective or academic core credit may be awarded as appropriate.

Degree Credit Requirements

Minimum credit requirements for a Bachelors degree are 100 academic credits and the Masters degrees are 40 academic credits beyond the Bachelor's. Minimum requirements for a Doctorate are 60 academic credits beyond the Bachelors or 20 credits beyond the Master's, which can include credits for the Dissertation and research.






